Whereas, the Athens Lions Club agrees that the resulting club shall continue under the existing charter granted by Lions Clubs International to the Athens Classic City Lions Club on February 9, 1965;

Whereas, the Athens Lions Club agrees that the current officers of the resulting Athens Classic City Lions Club shall complete their terms for the 2022-2023 Lions year;

Whereas, the Athens Lions Club agrees that meetings of the resulting Athens Classic City Lions Club shall remain the same, meeting at 6:00 pm on the second and fourth Mondays each month at the IHOP Restaurant at 1061 Parkway Boulevard in Athens, Georgia.

Whereas, per the requirements of Lions Clubs International, the Athens Lions Club shall pay any outstanding obligations, shall close its accounts upon the merger, and shall transfer all funds remaining to the Athens Classic City Lions Club; and

Whereas, per the requirements of Lions Clubs International, the Athens Lions Club shall dispose of all club property in an appropriate manner, shall file its closing Monthly Membership Report with the international office listing the members transferring to the remaining club, and shall turn its charter over to the 18-I District Governor.

Now, therefore, be it resolved that, upon the approval of the Lions District 18-I Cabinet and Lions Clubs International, the Athens Lions Club be merged with the Athens Classic City Lions Club.
